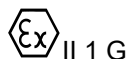

11 Description

The equipment is used to detect machine vibration and provide an indication of vibration levels. It consists of an electronic board and sensing element mounted in a stainless steel housing with a connector. The equipment operates by sensing the voltage from the internal accelerometer, which is produced by the vibrations from the machinery, and conditioning this voltage to provide an AC voltage superimposed on a DC bias voltage.
